# Village Board of Aldermen Regularly Scheduled Board of Aldermen Meeting Minutes

Mayor McCort called the meeting to order at 6:00, quorum present.

The Pledge of Allegiance and the Texas Pledge of Allegiance were recited. The invocation was given by Ray Don McIntosh of Salado Church of Christ.

### **Citizen Comments:**

Nicole Stairs, 525 Park Drive, Salado - Reporting on sales tax decline – research shows that the younger crowd coming in looking for entertainment, rather than antiques and artwork. They are more selective on where their money goes. Kudos to Johnny's Outback for providing an option for people to enjoy. Jim Boynton – 3565 FM 2843, Salado – Reporting on building code issues, lack of fairness of Johnny's Outback permitting process vs. building a home and the requirements therein. Violations of codes are numerous at Johnny's Outback. The Shed is also not being enforced and has violations. John Jennings – 351 Salado Creek Road, Salado – Issues with building permits for Johnny's Outback and The Shed. (Handouts provided.) 2. Recommendation to Form Subcommittee to Incorporate Changes to Zoning Ordinances Motion was made by Mayor ProTem Fritch to form a Subcommittee to Incorporate Changes to the Zoning Ordinances. Motion was seconded by Alderman Ashe; motion carried unanimously.

  Voice as the Village's official newspaper and Temple Daily Telegram as the secondary official
  newspaper. Motion was seconded by Alderman Ashe; motion carried unanimously.
- 5. Adoption of Resolution Adopting an Investment Policy and Investment Officer for Fiscal Year 2013-2014 Motion was made by Alderman McDougal to go into executive session to discuss this item. Motion was seconded by Alderman Brown; motion carried unanimously.

# **Public Hearing Items:**

- 7. Adoption of 2013-2014 Proposed General Fund and Hotel/Motel Budget Ordinance Second Reading Mayor McCort opened the public hearing. There were no comments from the floor. Mayor McCort closed the public hearing. The General Fund budget reflects a \$.12/\$100 ad valorem tax rate and is a deficit budget. Alderman McDougal spoke about the deficit budget, and noted that he felt there was not sufficient time spent by the Board of Alderman on the budget process. Motion was made by Mayor ProTem Fritch to adopt Ordinance No. 2013.07 adopting the 2013-2014 General Fund and Hotel/Motel budgets. Motion was seconded by Alderman Brown; motion carried 5-1 with Alderman McDougal voting against.
- 8. Adoption of 2013-2014 Proposed Ad Valorem Tax Rate Ordinance Second Reading
  Mayor McCort opened the public hearing. There were no comments from the floor.
  Mayor McCort closed the public hearing. Motion was made by Alderman Fields to adopt Ordinance
  No. 2013.06 adopting the 2013-2014 Ad Valorem Tax Rate Ordinance. Motion was seconded by
  Mayor ProTem Fritch; motion carried unanimously.
