#### 1. Update on After Action Plan

## 2. Year-to-Date Financials

The Board went over the financials for October. There were no objections.

# 3. Review Annex H

Mayor Ashe explained that annually the Board was to review and update the Village's Emergency Operations Plan. Annex H, Health & Medical Services was presented with minor format changes recommended. Alderman Stalcup requested that on page H-1 under Authority it be stated that the basic plan was approved by the State on such-and-such date. Alderman Cooper requested that on page H-15 under Annex Development & Maintenance, A., make the sentence read, "The Board of Aldermen are responsible for developing and maintaining this annex as applicable to the Village of Salado."

Motion was made by Alderman Epps to re-adopt Annex H as presented and with the above stated changes. Motion was seconded by Alderman Strong, motion carried unanimously.

## 4. Review Annex O

Annex O was presented. The changes the Board would like to see are: page 0-1-1, update phone numbers and stipulate who they belong to under Local Organizations and Groups; Page 0-8, under Task Assignment (1.) develop a Human Services Program/plan; page 0-10, complete the Line of Session (B.). These items will be implemented and brought back at a later date.

5. Update on Village Construction and Road Equipment Policy

The Village's policy on road equipment was presented with changes to reflect that the new maintenance department now has the responsibility to operate and maintain the equipment instead of the police department. A provision for emergencies after 5:00PM was put in to allow the police department to use the equipment. The Mayor or the Chief of Police must determine if a situation is an emergency.

Motion was made by Alderman Strong to adopt the Village Construction and Road Equipment Policy as presented with changes. Motion was seconded by Alderman Epps, motion carried unanimously.

6. Recommendation from Planning & Zoning Commission on DJ Fuller Subdivision
Bob Mitchell, the Engineer for the owner of DJ Fuller subdivision, gave the Board an overview of the proposed 7-lot subdivision located at the corner of Thomas Arnold & Salado School Road.
This subdivision is located in the Village's ETJ. The Planning & Zoning Commission recommends approval of the plat as presented.

Motion was made by Alderman Epps to approve the DJ Fuller Subdivision as presented. Motion was seconded by Alderman Stalcup, motion carried unanimously.
