Alderman Walls made a motion to approve the previous meeting minutes dated July 15th. Motion was seconded by Alderman Terry, motion carried unanimously.

#### **New Business:**

1. Sign Variance Request from Bush's Chicken

Larry Guess, owner of Bush's Chicken, has asked the Board for a variance to the Village's Sign Ordinance and allow him to put wording on the awning attached to the restaurant. Motion was made by Alderman Walls to grant the request and allow Bush's Chicken to put wording on the existing awning. Motion was seconded by Alderman Fritch; motion carried unanimously.

## 2. Bids on Trimming/Removing Trees in the Village

Mayor Stalcup explained that Roxanne Valdez, the Municipal Inspector, has listed four areas in town in need of tree trimming or removal. The Village does not have the appropriate equipment or man power to do this size of tree trimming/removal and suggested the Village hire it done. Two bids were placed for the work, Double J Tree Service with \$1800.00, and Heart of Texas Landscape with \$4200.00. The Board felt that the trees were off the road, therefore on private property and it is the property owners responsibility to trim or remove the trees.

Motion was made by Alderman Fritch to accept the low bid. Motion was seconded by Alderman Walls; motion failed.

3. Amend Zoning Ordinance Use Chart to Include "Sporting Goods Store" as Allowable in Local Retail Districts and to Allow Planning & Zoning Commission to Appoint their Chairman

This was the first reading to amend the ordinance. The ability for the P&Z to appoint their own chairman also applies to the ZBA. There were no objections.

4. <u>File 2010-2011 Proposed General Fund and Hotel/Motel Budgets with Village Secretary</u> Draft A of the General Fund proposed budget and Draft B of the Hotel/Motel proposed budget were presented to the Board.

Motion was made by Alderman Walls to file Draft A of the General Fund proposed budget as presented with the Village Secretary. Motion was seconded by Alderman McCort; motion carried unanimously.

Motion was made by Alderman Terry to file Draft B of the Hotel/Motel proposed budget as presented with the Village Secretary. Motion was seconded by Alderman Walls; motion carried unanimously.

5. Quarterly Investment Reports

Alderman Peters explained the Investment report for the General Fund and the Hotel/Motel Fund. There were no objections.
