1. Executive Session

Consultation with outside legal counsel regarding legal matters relating to the Master Development Agreement, Wastewater Service Agreement and 380 Economic Development Agreement for the Sanctuary Development, pursuant to Chapter 551.071 of the Texas Government Code. (Village Administrator)

Mayor Pro-tem Bell moved to approve amendments to the agreements between the Village of Salado and the Sanctuary as follows: the amendments to the Master Development Agreement as presented to the Board by legal counsel, with changes to Section F, Line 4 to change Section B to Section C, which is a typo; and amendments to the Wastewater Service Agreement and Chapter

380 Economic Development Agreement, as presented by legal counsel. Alderman Cox seconded the motion.

Mayor Pro-tem Bell thanked Mr. Caputo, Mr. Howard, Village Administrator Ferguson for their work on the amendments. Mr. Howard thanked the Board on behalf of the Sanctuary.

Mayor Coggin called for a vote as follows: Alderman Howard, aye; Alderman Graham, aye; Alderman Cole, aye; Alderman Cox, aye; and Mayor Pro-tem Bell, aye. Motion carried on a vote of 5-0.
